All items not removed from Port City Raceway by March 2, 2024 will be subject to an additional storage fee of \$10.00 per day. Any items not removed within 2 months of March 2, 2024, will become property of Port City Raceway.
3. ALL property stored on the premises shall be at the lessee's sole risk. Lessee understands and acknowledges by signing this agreement, that PCR shall not, does not, and will not carry insurance of any kind for the lessee's item(s) stored. In addition, PCR shall not be held liable to Lessee for any damage to, or loss of, any personal property stored during the term of this Agreement. PCR shall not be responsible for theft or damage to any of Lessee's property and Lessee expressly waives and releases PCR from any such claims. Lessee shall indemnify, hold harmless and defend PCR from all claims, demands, actions or causes of action (including attorney fees and all costs) that are brought by any party arising out of Lessee's use of the storage space at Port City Raceway in Tulsa, OK.
